RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF PRC PRE-PRINTED ID CARDS AND CONSUMABLES WITH FREE USE OF ID CARD PRINTING EQUIPMENT FOR CY 2017 TO ALLCARD PLASTICS PHILIPPINES, INC. WITH THE BID AMOUNT OF SIX MILLION FOUR HUNDRED TWENTY-SIX THOUSAND PESOS (\$\interprecep\$6,426,000.00)

WHEREAS, by virtue of the invitation to apply for eligibility and to bid through Public Bidding *in the Manila Times*, a newspaper of nationwide circulation, in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPS), Azitsorog, Inc. (Azitsorog), Allcard Plastics Philippines, Inc. (Allcard) and Omega Computer Corporation (OCC) participated in the Public Bidding for the project: Supply and Delivery of PRC Pre-printed ID Cards and Consumables with Free Use of ID Card Printing Equipment for CY 2017 for an Approved Budget for the Contract of Fourteen Million Pesos (₱14,000,000.00).

WHEREAS, on February 24, 2017 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, which was attended by five (5) prospective bidders namely, Omega Computer Corporation, Azitsorog, Inc., Allcard Plastics Phils., Inc., Gakken (Phils.), Inc. and Akinto Marketing.

WHEREAS, the BAC issued Bid Bulletins dated February 28, 2017, March 6, 2017, March 13, 2017 and March 15, 2017 for some modification/amendment on the bidding documents which were posted in the PHILGEPS and in the PRC website, thus, the scheduled submission and opening of bids was re-scheduled to March 30, 2017 at 10:00 o'clock in the morning.

WHEREAS, during the opening of bids on March 30, 2017, Azitsorog, OCC and Allcard, submitted their eligibility, technical and financial requirements.

WHEREAS, all the bidders have passed the eligibility and technical evaluation, the BAC opened their financial bid proposals, and the result of which are:

- 1. Azitsorog, Inc. ₱11,116,000.00
- 2. Allcard Plastics Philippines, Inc. ₱6,426,000.00
- 3. Omega Computer Corporation ₱10,493,000.00

WHEREAS, Allcard was declared to be the Lowest Calculated Bidder and was subjected to post-qualification on April 19, 2017 at Lot 3, Blk. 17, E. Rodriguez Jr. Avenue, corner Titan St., Acropolis Subdivision, Bagumbayan, D3, Quezon City.

WHEREAS, Allcard Plastics Philippines, Inc. passed the post-qualification, and was declared to be the Lowest Calculated and Responsive Bidder.
