

**CONTRACT FOR THE PROCUREMENT OF VARIOUS FURNITURE AND FIXTURES –
LOT 4: TWENTY FOUR (24) UNITS OF STEEL FILING CABINET-VERTICAL, AND
SEVEN (7) UNITS OF STEEL FILING CABINET-FOUR DRAWERS WITH VAULT**

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into by and between:

PROFESSIONAL REGULATION COMMISSION, an agency of the National Government, hereinafter referred to as **PRC**, with principal office address at P. Paredes st., Sampaloc, Manila, represented by its Chairman, **HON. TEOFILO S. PILANDO, JR.**;

- and -

DESIGN EXCELLENCE HOME & OFFICE SYSTEM, CO. (DESIGN), a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at 1 Binmaka St., cor. Biak Na Bato, Barangay Manresa, Quezon City, herein represented by its Project & Sales Consultant, **MS. MA. LUIZA ANGELES**.

WITNESSETH THAT:

WHEREAS, PRC invited bids for the Procurement of Various Furniture and Fixtures – Lot 4: Twenty-Four (24) Units of Steel Filing Cabinet-Vertical, and Seven (7) Units of Steel Filing cabinet-Four Drawers with Vault, and has accepted the bid of **DESIGN** for the supply of goods in the amount of **THREE HUNDRED FORTY THREE THOUSAND TWO HUNDRED NINETY PESOS (Php.343,290.00)**. (Hereinafter called “the Contract Price”)

WHEREAS, upon evaluation and recommendation of the Bids and Awards Committee, and approval of the Commission, **DESIGN** was declared to be the Lowest Calculated and Responsive Bidder for the project: Procurement of Various Furniture and Fixtures – Lot 4: Twenty-Four (24) Units of Steel Filing Cabinet-Vertical, and Seven (7) Units of Steel Filing cabinet-Four Drawers with Vault.

NOW, THEREFORE, for and in consideration of the abovementioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRC** and **DESIGN** have agreed as follows:

1. The words, phrases and expression in this Agreement shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents, herein attached as “Annexes A-G” shall be deemed to form and be read and construed as part of this Agreement. viz :
