

CONTRACT FOR SECURITY SERVICES 2017

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into by and between:

PROFESSIONAL REGULATION COMMISSION, an agency of the National Government, hereinafter referred to as **PRC**, with principal office address at P. Paredes, Sampaloc, Manila, represented by its Chairman, **HON. TEOFILO S. PILANDO, JR.**;

-and-

REGION SECURITY AND INVESTIGATION AGENCY, hereinafter referred to as **RSIA**, a sole proprietorship duly organized and existing under the laws of the Republic of the Philippines, with principal address at No. 37 Diversion Road, Caritan Centro, Tuguegarao City, Cagayan, herein represented by its Proprietor, **MR. ROMEO S. PAGALILAUAN**.

WITNESSETH THAT:

WHEREAS, PRC invited Bids for the Provision of Security Services for the year 2017 for PRC Tuguegarao Regional Office as described and enumerated in Section VI or the Schedule of Requirements, and has accepted the Bid of **RSIA** for the goods and services in the sum of **SIX HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED EIGHTY THREE AND FIFTY TWO CENTAVOS (₱681,983.52) ONLY**. (Hereinafter called "the Contract Price");

WHEREAS, upon evaluation and recommendation of the Regional Bids and Awards Committee of PRC Tuguegarao Regional Office, and approval of the Commission, **RSIA** was declared to be the single calculated and responsive bidder for the project Provision of Security Services 2017 as described and enumerated in Section VI or the Schedule of Requirements;

NOW THEREFORE, for and in consideration of the above mentioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRC** and **RSIA** have agreed as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents, herein attached as Annexes "A-G" shall be deemed to form and be read and construed as part of this Agreement. viz:
 - A. The Bid Form and the Price Schedule submitted by **RSIA**;
 - B. The Schedule of Requirements acknowledged by **RSIA**;
 - C. The Technical Specifications acknowledged by **RSIA**;
 - D. The General Conditions of Contract;



- E. The Special Conditions of Contract;
- F. PRC's Notification of Award; and
- G. The Affidavit of Undertaking executed by **RSIA**.

3. In consideration of the payments to be made by the **PRC**, **RSIA** hereby agrees to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of this Contract.


