

CONTRACT FOR THE PROVISION OF SECURITY SERVICES 2017

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into by and between:

PROFESSIONAL REGULATION COMMISSION, an agency of the National Government, hereinafter referred to as **PRC**, with principal office address at P. Paredes, Sampaloc, Manila, represented by its Chairman, **HON. TEOFILO S. PILANDO, JR.**;

-and-

GOD'S WELL INVESTIGATION SECURITY AGENCY, a sole proprietorship duly organized and existing under the laws of the Republic of the Philippines, hereinafter referred to as **GWISA** with principal address at Ground Floor FICCO Building, R. Chavez Street, Brgy. 30, Cagayan de Oro City herein represented by its Proprietor, **MR. CHRISTOPHER E. YAMIT**.

WITNESSETH THAT:

WHEREAS, PRC invited Bids for the Provision of Security Services for the year 2017 for PRC Cagayan de Oro Regional Office, and has accepted the Bid of **God's Well Investigation Security Agency** for the supply of goods and services in the sum of **ONE MILLION ONE HUNDRED THIRTY TWO THOUSAND SEVEN HUNDRED THIRTY SIX PESOS AND EIGHTY-NINE CENTAVOS ONLY (₱1,132,736.89)**. (Hereinafter called "the Contract Price").

WHEREAS, upon evaluation and recommendation of the Regional Bids and Awards Committee of PRC Cagayan de Oro Regional Office, and approved by the Commission, **GWISA** was declared to be the single calculated and responsive bidder for the project Provision of Security Services 2017.

NOW THEREFORE, for and in consideration of the above mentioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRC** and **GWISA** have agreed as follows:

- G. The Affidavit of Undertaking executed by **GWISA**.

3. In consideration of the payments to be made by the **PRC**, **GWISA** hereby agrees to provide the services in conformity in all respects and purposes with the provisions of this Contract.
