Resolution No. 2017 - 43

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF CONTRACT FOR THE ENGAGEMENT OF A CERTIFYING BODY FOR A THIRD PARTY AUDIT CERTIFICATION UNDER ISO 9001:2015 QUALITY MANAGEMENT SYSTEM OF FOUR (4) REGIONAL OFFICES OF THE PROFESSIONAL REGULATION COMMISSION IN THE CITIES OF TUGUEGARAO, LUCENA, TACLOBAN AND CAGAYAN DE ORO TO CERTIFICATION INTERNATIONAL PHILIPPINES, INC., WITH THE BID AMOUNT OF ONE MILLION THREE HUNDRED TWENTY-ONE THOUSAND SIX HUNDRED PESOS (P1,321,600.00)

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board, Certification International Philippines, Inc. (CIP) and TUV SUD PSB Philippines, Inc. participated in the Public Bidding for the project: Engagement of a Certifying Body for a Third Party Audit Certification Under ISO 9001:2015 Quality Management System of Four (4) Regional Offices of the Professional Regulation Commission in the Cities of Tuguegarao, Lucena, Tacloban, and Cagayan de Oro for an Approved Budget for the Contract of One Million Eight Hundred Seventy-Nine Thousand and Two Hundred Pesos (P1,879,200.00).

WHEREAS, on July 26, 2017, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, which was attended by the representatives from Certification International Philippines, Inc. and TUV SUD PSB Philippines, Inc.

WHEREAS, during the opening of bids on August 7, 2017, Certification International Philippines, Inc. and TUV SUD PSB Philippines, Inc. submitted its eligibility, technical, and financial requirements. However, TUV SUD PSB Philippines, Inc. failed to submit supporting documents of its compliance in the completion of delivery and end user's acceptance of their completed contract, statement of none applicability of JVA, and non-conformity with item No. 1.5 of the Technical Specifications, thus the BAC did not proceed with the opening of its financial bid proposal and was declared failed with its eligibility requirements.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, the BAC gave TUV SUD PSB Philippines, Inc. three (3) calendar days within which to file a motion for reconsideration. However, TUV SUD PSB Philippines failed to file a motion for reconsideration within the three days period granted to it.

WHEREAS, only the financial proposal of CIP, having passed the eligibility and technical requirements, was opened with the bid amount of One Million Three Hundred Twenty-One Thousand Six Hundred Pesos (₱1,321,600.00).

WHEREAS, Certification International Philippines, Inc. was declared to be the Single Calculated Bidder and thus subjected to post-qualification.

WHEREAS, a site inspection was conducted in the afternoon of August 8, 2017 at the 8th Floor, OMM-CITRA Building, San Miguel Avenue, Ortigas Center, Pasig City, to verify, validate and ascertain all statements made, and documents submitted by bidder during the submission and opening of Bids in its Eligibility, Technical and Financial Envelopes including the additional documentary requirements that will be submitted by the bidder during post-qualification.

WHEREAS, Certification International Philippines, Inc., having passed the post qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of contract for the Engagement of a Certifying Body for a Third Party Audit Certification Under ISO 9001:2015 Quality Management System of Four (4) Regional Offices of the Professional Regulation Commission in the Cities of Tuguegarao, Lucena, Tacloban, and Cagayan de Oro to **CERTIFICATION INTERNATIONAL PHILIPPINES, INC.**, with the bid amount of **ONE MILLION THREE HUNDRED TWENTY-ONE THOUSAND SIX HUNDRED PESOS (₱1,321,600.00)**.


