RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF MATERIALS FOR THE REHABILITATION BY ADMINISTRATION OF PRC CENTRAL OFFICE BUILDING ELECTRICAL SYSTEM TO LUZON SALES COMPANY, INC., WITH A TOTAL BID AMOUNT OF FOUR MILLION ONE HUNDRED TEN THOUSAND PESOS (Php4,110,000.00)

WHEREAS, by the virtue of the invitation to apply for eligibility to bid through Public Bidding published in the PRC website, in the Philippine Government Electronic Procurement System (PhilGEPS) and in the conspicuous place in PRC premises, Luzon Sales Company, Inc., (Luzon Sales) participated for the project: Procurement of Materials for the Rehabilitation By Administration of PRC Central Office Building Electrical System with a Total Approved Budget for the Contract of Four Million One Hundred Twenty Two Thousand Four Hundred Thirty One Pesos (Php4,122,431.00).

WHEREAS, on December 08, 2017 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidder may have which was attended by one (1) prospective bidder namely; Luzon Sales. Thus, only Luzon Sales purchased the Bid Documents.

WHEREAS, the BAC issued Bid Bulletin No.1 dated December 18, 2017 reflecting the amendments on the date of Submission and Opening of Bids from December 20, 2017 to December 27, 2017.

WHEREAS, during the opening of bids on December 27, 2017, Luzon Sales submitted its eligibility, technical and financial requirements.

WHEREAS, Luzon Sales having passed the eligibility and technical evaluation, the BAC opened its financial bid proposal.

WHEREAS, Luzon Sales total bid price is **FOUR MILLION ONE HUNDRED TEN THOUSAND PESOS (Php4,110,000.00)**. Hence, Luzon Sales was declared as the Single Calculated Bidder and was subjected to post-qualification later on that day to verify, validate and ascertain all statements made in its Eligibility and Technical Bid Envelopes, during the submission and opening of bids, including the additional documentary requirements submitted by the bidder. Luzon Sales submitted its original Eligibility, Technical, and additional documentary requirements.

WHEREAS, Luzon Sales passed the post-qualification, and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award to Luzon Sales Company, Inc., the contract for the Procurement of Materials for the Rehabilitation By Administration of PRC Central Office Building Electrical System with the Total Bid Amount of **FOUR MILLION ONE HUNDRED TEN THOUSAND PESOS (Php4,110,000.00)**.
