Resolution No. 2017 - 77

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF VARIOUS FURNITURE AND FIXTURE: LOT 5 – TEN (10) SETS OF DOUBLE DECK, AND SEVEN (7) SETS OF SINGLE BED TO GEMSTONE ENTERPRISE WITH TOTAL BID AMOUNT OF TWO HUNDRED SIXTY-EIGHT THOUSAND ONE HUNDRED TWENTY-FIVE PESOS (Php.268,125.00)

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPs), and in the Bids and Awards Committee (BAC) Bulletin Board, Design Excellence Home & Office System Company (Design), Asahi Design Centre Inc. (Asahi), Gemstone Enterprise (Gemstone), and TJTF Trading (TJTF) participated the Public Bidding for the project: Procurement of Various Furniture and Fixture: Lot 5 – Ten (10) Sets of Double Deck, and Seven (7) Sets of Single Bed with approved budget for the contract of Three Hundred Eighty-Five Thousand Six Hundred Fifty Pesos (Php385,650.00)

WHEREAS, on December 7, 2017, a pre-bid conference was held, to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have and was attended by six (6) prospective bidders namely: Filcrafters, Inc., Gemstone Enterprise, Asahi, Design, Cubix and Distinctive. Thus, Design, Asahi, Gemstone, and TJTF purchased the Bid Documents.

WHEREAS, on December 13, 2017 the BAC issued Bid Bulletin No. 1 for the design and picture of the items to be procured and also the rescheduling of submission and opening of bids from December 19, 2017 to December 21, 2017.

WHEREAS, on December 18, 2017 the BAC issued Bid Bulletin No. 2 for the rescheduling of the submission and opening of bids from December 21, 2017 to December 27, 2017.

WHEREAS, on December 27, 2017, during the Submission and Opening of Bids, Design, Asahi, Gemstone and TJTF submitted their eligibility, technical and financial requirements.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. On the other hand, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, during the opening and evaluation of bids TJTF failed to pass the eligibility and technical evaluation (**ANNEX "A"**), the BAC did not open its financial bid proposals. Design, Asahi, and Gemstone having passed the eligibility and technical evaluation, the BAC opened their financial bid proposals which were as follows:

1. Design Php385,000.00
2. Asahi Php 372,880.00
3. Gemstone Php268,125.00

WHEREAS, Gemstone having the lowest financial bid was declared as the Lowest Calculated Bidder and thus subjected to post-qualification.


WHEREAS, on December 28, 2017, a post-qualification was conducted at Gemstone Unit 7 Vava Building, Verdant Acres Pamplona 3, Las Piñas City, to verify, validate and ascertain all statements made in its Eligibility and Technical Bid Envelopes submitted by bidder during the submission and opening of bids, including the additional documentary requirements submitted by the bidder.

WHEREAS, Gemstone having passed the post-qualification was declared to be the Lowest Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of the contract for the **PROCUREMENT OF VARIOUS FURNITURE AND FIXTURE LOT 5 – TEN (10) SETS OF DOUBLE DECK, AND SEVEN (7) SETS OF SINGLE BED** to **GEMSTONE ENTERPRISE** with bid amount of **TWO HUNDRED SIXTY-EIGHT THOUSAND ONE HUNDRED TWENTY-FIVE PESOS (Php.268,125.00) ONLY**.
