Resolution No. 2017 - 72

**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF VARIOUS IT EQUIPMENT (REBID) – LOT 7: SUPPLY AND DELIVERY OF TWENTY SEVEN (27) UNITS UPS FOR SERVER TO SIM COMPUTER SALES, INC. WITH TOTAL BID AMOUNT OF TWO MILLION NINETY THOUSAND AND EIGHT HUNDRED EIGHTY PESOS (Php.2,090,880.00)**

**WHEREAS**, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the Manila Times, a newspaper of general circulation, in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board, only SIM COMPUTER SALES, INC. (SIM) participated in the Public Bidding for the project: Procurement of Various IT Equipment (Rebid) – Lot 7: Supply and Delivery of Twenty-Seven (27) Units UPS for Server with an Approved Budget for the Contract (ABC) of Two Million One Hundred Six Thousand Pesos (P2,106,000.00).

**WHEREAS**, the BAC issued Bid Bulletin No. 1, for the postponement of the scheduled pre-Bid conference from December 8, 2017 to December 13, 2017, and opening of bids from December 20, 2017 to December 26, 2017.

**WHEREAS**, on December 13, 2017, a pre-bid conference was held, to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, which was attended by the representatives from SIM.

**WHEREAS**, upon discussion during the pre-bid conference with the prospective bidder and the end users, the BAC agreed for some modifications/amendments on the technical specifications. Thus, Bid Bulletin No. 2 dated December 13, 2017 was issued.

**WHEREAS**, to encourage the participation of more bidders, the BAC issued Bid Bulletin No. 3, for further revisions of the technical specifications and the re-scheduling of the opening of bids on December 27, 2017 at 1:00 o'clock in the afternoon.

**WHEREAS**, during the submission and opening of bids on December 27, 2017, only SIM Computer Sales, Inc., submitted its eligibility, technical, and financial requirements, with a bid price of Two Million Ninety Thousand and Eight Hundred Eighty Pesos (Php.2,090,880.00).

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act" requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. On the other hand, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

**WHEREAS**, SIM Computer Sales, Inc., having passed the eligibility and technical evaluation, was declared as the Single Calculated Bidder, and was subjected to post-qualification.

**WHEREAS**, on December 28, 2017, a post-qualification was conducted at SIM, located at the 3/F Metrostar Building, 1007 Metropolitan Avenue, Makati City, to verify, validate and ascertain all statements made in its Eligibility and Technical Bid Envelopes during the submission and opening of bids, including the additional documentary requirements that were submitted by the bidder.

**WHEREAS**, SIM Computer Sales, Inc., having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROCUREMENT OF VARIOUS IT EQUIPMENT (REBID) – LOT 7: SUPPLY AND DELIVERY OF TWENTY SEVEN (27) UNITS UPS FOR SERVER to SIM COMPUTER SALES, INC.** with a total bid amount of **TWO MILLION NINETY THOUSAND AND EIGHT HUNDRED EIGHTY PESOS (Php.2,090,880.00)**.
