**Resolution No. 2017 - 73**

**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF VARIOUS IT EQUIPMENT (REBID) – LOT 8: SUPPLY AND DELIVERY OF THIRTY FIVE (35) UNITS PROJECTOR TO THE VALUE SYSTEMS PHILS., INC. WITH A TOTAL BID AMOUNT OF SEVEN HUNDRED THIRTY FIVE THOUSAND PESOS (Php.735,000.00)**

**WHEREAS**, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the Manila Times, a newspaper of general circulation, in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board, SIM COMPUTER SALES, INC. (SIM) and THE VALUE SYSTEMS PHILS., INC. participated in the Public Bidding for the project: Procurement of Various IT Equipment (Rebid) – Lot 8: Supply and Delivery of Thirty-Five (35) Units Projector with an Approved Budget for the Contract (ABC) of Eight Hundred Seventy-Five Thousand Pesos (P875,000.00).

**WHEREAS**, the BAC issued Bid Bulletin No. 1, for the postponement of the scheduled pre-Bid conference from December 8, 2017 to December 13, 2017, and opening of bids from December 20, 2017 to December 26, 2017.

**WHEREAS**, on December 13, 2017, a pre-bid conference was held, to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, which was attended only by the representatives from SIM.

**WHEREAS**, the BAC issued Bid Bulletins No. 2 and No. 3 dated December 13, 2017 and December 18, 2017, respectively, for some modifications/amendments on the bidding documents which were posted in the PhilGEPS and in the PRC website. Thus, the scheduled submission and opening of bids was re-scheduled to December 27, 2017 at 1:00 o'clock in the afternoon.

**WHEREAS**, during the submission and opening of bids on December 27, 2017, SIM Computer Sales, Inc. and The Value Systems Phils., Inc., submitted their eligibility, technical and financial requirements.

**WHEREAS**, both bidders having passed the eligibility and technical evaluation, the BAC opened their financial bid proposals, and the result of which are:

1. SIM Computer Sales, Inc. – P870,000.00
2. The Value Systems Phils., Inc. – P735,000.00

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. On the other hand, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".



**WHEREAS**, the Value Systems Phils., Inc. having passed the post-qualification, was declared to be the Lowest Calculated and Responsive Bidder.

**WHEREAS**, on December 28, 2017, a post-qualification was conducted at The Value Systems Phils., Inc., located at the 3434 R. Magsaysay Blvd., Sta. Mesa, Manila, to verify, validate and ascertain all statements made in its Eligibility and Technical Bid Envelopes during the submission and opening of bids, including the additional documentary requirements that were submitted by the bidder.

**WHEREAS**, the Value Systems Phils., Inc., having passed the post-qualification, was declared to be the Lowest Calculated and Responsive Bidder.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of the contract for the **PROCUREMENT OF VARIOUS IT EQUIPMENT (REBID) – LOT 8: SUPPLY AND DELIVERY OF THIRTY-FIVE (35) UNITS PROJECTOR to THE VALUE SYSTEMS PHILS., INC.** with a total bid amount of **SEVEN HUNDRED THIRTY-FIVE THOUSAND PESOS (Php.735,000.00)**.
