RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF THE CONTRACT FOR THE PROVISION OF JANITORIAL SERVICES (2017) TO D' TRIUMPH CLEANERS AND ALLIED SERVICES, INC. WITH THE TOTAL BID AMOUNT OF FOUR MILLION NINE HUNDRED SEVENTY SIX THOUSAND SEVEN HUNDRED SEVENTY FIVE PESOS AND SEVENTY FIVE CENTAVOS (Php4,976,775.75)

WHEREAS, by virtue of the invitation to apply for eligibility and to bid through Public Bidding published in the Professional Regulation Commission (PRC) website, in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board, D' Triumph Cleaners and Allied Services, Inc. (D' Triumph) and Anchor Human Resources Dev't. Corp. (Anchor) participated for the project: Provision of Janitorial Services (2017) with an Approved Budget for the Contract of Six Million Seventy-Seven Thousand Five Hundred Fourteen Pesos and Seventy-Two Centavos (Php6,077,514.72).

WHEREAS, on December 8, 2017 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidder may have and which was attended by representatives from D' Triumph, M8 Manpower Services and Anchor Human Resources Dev't. Corp.

WHEREAS, during the submission and opening of the bids on December 20, 2017, D' Triumph and Anchor Human Resources submitted their eligibility, technical and financial requirements.

WHEREAS, both bidders having passed the eligibility and technical evaluation, the BAC opened their financial bid proposals, and the result of which are:

1. D' Triumph Cleaners and Allied Services, Inc. – ₱4,976,775.75
2. Anchor Human Resources Dev't. Corp. – ₱4,981,391.51

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. On the other hand, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, D' Triumph was declared to be the Lowest Calculated Bidder and was subjected to post-qualification on December 27, 2017 to verify, validate and ascertain all statements made in its Eligibility and Technical Bid Envelopes submitted by the bidder during the submission and opening of bids, including the additional documentary requirements submitted by the bidder.
