RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE PROCUREMENT VARIOUS IT PROJECTS: LOT 1 – TWENTY-FIVE (25) UNITS OF COLORED LASERJET PRINTER TO BUSINESS MACHINES CORPORATION WITH TOTAL BID AMOUNT OF ONE MILLION ONE HUNDRED FORTY-SEVEN THOUSAND TWO HUNDRED PESOS (Php.1,147,200.00) ONLY.

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board, only Business Machines Corporation (BISMAC) participated in the Public Bidding for the project: Procurement of Various IT Projects: Lot 1 – Twenty-Five (25) Units of Colored Laserjet Printer with approved budget of One Million One Hundred Fifty Thousand Pesos (Php.1,150,000.00).

WHEREAS, on November 17, 2017, a pre-bid conference was held, to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have which was attended by two (2) representative bidders namely: HP Makati City and BISMAC. However only BISMAC purchased the Bid Documents.

WHEREAS, on November 29, 2017, during the Submission and Opening of Bids, only BISMAC submitted its eligibility, technical and financial requirements.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, during the opening and evaluation of bid BISMAC having passed the eligibility and technical evaluation, the BAC opened its financial bid proposal of **ONE MILLION ONE HUNDRED FORTY-SEVEN THOUSAND TWO HUNDRED PESOS (Php1,147,200.00) ONLY** was declared as the Single Calculated Bidder and thus subjected to post-qualification.

WHEREAS, on December 1, 2017, a post-qualification was conducted at BISMAC Carson Bldg. Orense cor. Del Carmen St., Guadalupe Nuevo Makati City, to verify, validate and ascertain all statements made, and documents submitted by bidder during the submission and opening of bids in its Eligibility, Technical and Financial Envelopes including the additional documentary requirements that will be submitted by the bidder during post-qualification.

WHEREAS, BISMAC having passed the post-qualification was declared to be the Single Calculated and Responsive Bidder.
