RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION THE AWARD OF CONTRACT FOR THE PROCUREMENT FOR THE SUPPLY, INSTALLATION AND IMPLEMENTATION OF SERVER VIRTUALIZATION INFRASTRUCTURE – REBID TO MACROLOGIC DIVERSIFIED TECHNOLOGIES INC. WITH THE TOTAL BID AMOUNT OF FOUR MILLION SIX HUNDRED TWENTY THOUSAND PESOS (Php4,620,000.00)

WHEREAS, by the virtue of the invitation to apply for eligibility to bid through Public Bidding published in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPs), Sim Computer Sales Inc. and Macrologic Diversified Technologies Inc. participated for the project: Procurement for the Supply, Installation and Implementation of Server Virtualization Infrastructure – Rebid with an Approved Budget for the Contract of Four Million Six Hundred Twenty Five Thousand Pesos (Php4,625,000.00) only.

WHEREAS, on February 15, 2017 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have which was attended by Unison Computer System, Inc., Sim Computer Sales Inc. (SIM), NOW Corporation, TEK Zone and Macrologic Diversified Technologies Inc. (Macrologic).

WHEREAS, SIM, Macrologic and Integrated Computer Systems Inc. are the bidders who purchased the Bid Documents.

WHEREAS, as a result of the discussion during the pre-bid conference, the Bids and Awards Committee (BAC) issued Bid Bulletin No.1 dated February 23, 2017 reflecting the modifications/amendments on the Technical Specifications in the bidding documents and rescheduling the opening of the bids from February 27, 2017 to March 7, 2017 at 10:00 A.M. The same was posted in PhilGeps and PRC website.

WHEREAS, on March 7, 2017, during the Opening of Bids, SIM and Macrologic submitted their eligibility, technical and financial requirements.

WHEREAS, Macrologic having passed the eligibility and technical evaluation, the BAC opened their financial bid proposal. On the other hand, SIM failed to use the appropriate forms provided in Section 19.1 of the Instruction to Bidders. Thus, SIM was declared disqualified and was given a three (3) days to file for Motion for Reconsideration.

WHEREAS, on March 9, 2017, SIM submitted a letter for reconsideration for the said project. However, on March 16, 2017 the BAC issued a Resolution No. 17 denying the motion for reconsideration filed by SIM for the Procurement for the Supply, Installation and Implementation of Server Virtualization Infrastructure – Rebid.

WHEREAS, Macrologic with a bid price of **FOUR MILLION SIX HUNDRED TWENTY THOUSAND PESOS (Php4,620,000.00)** was declared as the Single Calculated Bidder and was subjected to post-qualification on March 20, 2017 at B3 L55 Sorrento Ave., Sorrento Homes Panapaan, Aguinaldo Hiway, Bacoor Cavite.

WHEREAS, during the post-qualification, the BAC checked the original documents as against the certified true copies. After having passed all the eligibility and technical documents Macrologic was scheduled for Demonstration of installation and implementation of server virtualization on March 29, 2017 as part of post-qual requirement.

WHEREAS, on March 29, 2017, Macrologic passed the post-qualification and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it now **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, the award of contract for the Procurement for the Supply, Installation and Implementation of Server Virtualization Infrastructure – Rebid to Macrologic Diversified Technologies Inc. with the total bid amount of **FOUR MILLION SIX HUNDRED TWENTY THOUSAND PESOS (Php4,620,000.00)** only.
