RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE SUPPLY AND DELIVERY OF PRC PRE-PRINTED ID CARDS AND CONSUMABLES WITH FREE USE OF ID CARD PRINTING EQUIPMENT FOR CY 2018 TO ALLCARD INC. WITH THE TOTAL BID AMOUNT OF THIRTEEN MILLION ONE HUNDRED EIGHTY THOUSAND PESOS (PHP13,180,000.00)

WHEREAS, by virtue of the invitation to apply for eligibility and to bid through Public Bidding *in the Manila Times*, a newspaper of nationwide circulation, in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPS), Allcard Inc. (Allcard) participated in the Public Bidding for the project: Supply and Delivery of PRC Pre-printed ID Cards and Consumables with Free Use of ID Card Printing Equipment for CY 2018 for an Approved Budget for the Contract of Thirteen Million Three Hundred Fifty Thousand Pesos (Php13,350,000.00).

WHEREAS, on December 19, 2017 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, which was attended by five (5) prospective bidders namely, Allcard, REMAX Int'l., Omega Computer Corporation, Philcopy Corp. and Megacarte Smartcard Corporation.

WHEREAS, the BAC issued Bid Bulletins dated January 3, 2018 and January 8, 2018 for some modification/amendment on the bidding documents, and the postponement of the scheduled opening of bids from January 5, 2018 to January 11, 2018, and then later on re-scheduled to January 16, 2018 at 10:00 o'clock in the morning.

WHEREAS, during the opening of bids on January 16, 2018, Allcard, submitted its eligibility, technical and financial requirements.

WHEREAS, Allcard having passed the eligibility and technical evaluation, the BAC opened its financial bid proposal with a bid price of **THIRTEEN MILLION ONE HUNDRED EIGHTY THOUSAND PESOS** (Php13,180,000.00). Hence, Allcard was declared to be the Single Calculated Bidder and was subjected to post-qualification on January 23, 2018 at L-3 B-17 E. Rodriguez Jr. Ave. cor. Titan St., Acropolis Subd., Brgy. Bagumbayan, Quezon City.

WHEREAS, Allcard Inc. passed the post-qualification, and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, **TO RECOMMEND TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF PRC PRE-PRINTED ID CARDS AND CONSUMABLES WITH FREE USE OF ID CARD PRINTING EQUIPMENT FOR CY 2018 TO ALLCARD INC. WITH THE TOTAL BID AMOUNT OF THIRTEEN MILLION ONE HUNDRED EIGHTY THOUSAND PESOS (PHP13,180,000.00).**
