This Contract made and entered into by and between:

**BUSINESS MACHINES CORP.**, a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at Carson Building, Orense cor. Del Carmen St., Guadalupe Nuevo, Makati City 1212, herein represented by its Authorized Representative, **MS. MYLENE PALALAY**.


**WITNESSETH THAT:**

**WHEREAS**, PRC invited bids for the Procurement of Office Supplies for CY 2017: Lot 1 – Brother Toner, TN, 3448 (Original) compatible with Brother HL-L6400DW High Volume Monochrome Laser Printer, and has accepted the bid of **BUSINESS MACHINES CORP.** for the supply of goods in the amount of **SIX MILLION TWO HUNDRED SIXTY-EIGHT THOUSAND ONE HUNDRED EIGHTY-FIVE PESOS (Php.6,268,185.00)** only. (Hereinafter called “the Contract Price”).

**WHEREAS**, upon evaluation and recommendation of the Bids and Awards Committee, and approval of the Commission, **BUSINESS MACHINES CORP.** was declared to be the Single Calculated and Responsive Bidder for the project: Procurement of Office Supplies for CY 2017: Lot 1 – Brother Toner, TN, 3448 (Original) compatible with Brother HL-L6400DW High Volume Monochrome Laser Printer.
