**KNOW ALL MEN BY THESE PRESENTS:**

This Contract made and entered into by and between:

**PROFESSIONAL REGULATION COMMISSION**, an agency of the National Government, hereinafter referred to as **PRC**, with principal office address at P. Paredes, (former Morayta St.), Sampaloc, Manila, represented by its Chairman, **HON. TEOFILO S. PILANDO, JR.**;

- and -

**BUSINESS MACHINES CORP.**, a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at Carson Building, Orense cor. Del Carmen St., Guadalupe Nuevo, Makati City 1212, herein represented by its Authorized Representative, **MS. MYLENE PALALAY**.

**WITNESSETH THAT:**

**WHEREAS**, PRC invited bids for the Procurement of Office Supplies for CY 2017: Lot 2 – Colored Toner, HP CF 400A-403A, (Original) compatible with HP PRO 200 M252DW Laser Printer, and has accepted the bid of **BUSINESS MACHINES CORP.** for the supply of goods in the amount of **SIX MILLION FIVE HUNDRED THIRTY-EIGHT THOUSAND AND EIGHTY PESOS (Php.6,538,080.00)** only. (Hereinafter called “the Contract Price”).

**WHEREAS**, upon evaluation and recommendation of the Bids and Awards Committee, and approval of the Commission, **BUSINESS MACHINES CORP.** was declared to be the Single Calculated and Responsive Bidder for the project: Lot 2 – Colored Toner, HP CF 400A-403A, (Original) compatible with HP PRO 200 M252DW Laser Printer.

**NOW, THEREFORE**, for and in consideration of the abovementioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRC** and **BUSINESS MACHINES CORP.** have agreed as follows:

- D. The General Conditions of Contract acknowledged by **BUSINESS MACHINES CORP.;**
- E. The Special Conditions of Contract acknowledged by **BUSINESS MACHINES CORP.;**
- F. PRC's Notice of Award;
- G. The Affidavit of Undertaking executed by **BUSINESS MACHINES CORP.;** and
- H. Secretary's Certificate of **BUSINESS MACHINES CORP.**

3. In consideration of the payments to be made by the PRC, **BUSINESS MACHINES CORP.** hereby agrees to provide the goods and to remedy defects therein in conformity in all respects with the provisions of this Contract.


