**KNOW ALL MEN BY THESE PRESENTS:**

This Contract made and entered into by and between:

**PROFESSIONAL REGULATION COMMISSION**, an agency of the National Government, hereinafter referred to as **PRC**, with principal office address at P. Paredes, (former Morayta St.), Sampaloc, Manila, represented by its Chairman, **HON. TEOFILO S. PILANDO, JR.**;

- and -

**NATION PAPER PRODUCTS & PRINTING CORP.**, a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at #34 Narciso St. East Canumay, Valenzuela City, herein represented by its Authorized Representative, **MR. JOSEPH TAN.**

**WITNESSETH THAT:**




