KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into by and between:

PROFESSIONAL REGULATION COMMISSION, an agency of the National Government, hereinafter referred to as **PRC**, with principal office address at P. Paredes, (former Morayta St.), Sampaloc, Manila, represented by its Chairman, **HON. TEOFILO S. PILANDO, JR.**;

- and -

VIBAL GROUP, INC., hereinafter referred to as **VIBAL**, a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at 1253 G. Araneta Avenue, Quezon City, herein represented by its Business Development Representative, **MR. ARIEL S. ARAGO**.

WITNESSETH THAT:

WHEREAS, PRC invited bids for the Printing and Shredding of Test Booklets for the September 24, 2017 Board Licensure Examination for Professional Teachers (BLEPT), and has accepted the bid of **VIBAL GROUP, INC.** for the supply of goods and services in the sum of **SIX MILLION FOUR HUNDRED SIXTY-SEVEN THOUSAND SIX HUNDRED THIRTY-EIGHT PESOS AND SEVENTY-SIX CENTAVOS (P6,467,638.76)** at **FORTY-FOUR CENTAVOS (P0.44)** per page for printing and **TWO PESOS and THIRTY CENTAVOS (P2.30)** for the shredding of Test Booklets per examinee. (Hereinafter called "the Contract Price").

WHEREAS, upon evaluation and recommendation of the Bids and Awards Committee, and approval of the Commission, **VIBAL** was declared to be the Single Calculated and Responsive Bidder for the Project: Printing and Shredding of Test Booklets for the September 24, 2017 BLEPT.

NOW, THEREFORE, for and in consideration of the abovementioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRC** and **VIBAL** have agreed as follows:

 - D. The General Conditions of Contract acknowledged by **VIBAL**;
 - E. The Special Conditions of Contract acknowledged by **VIBAL**;
 - F. PRC's Notice of Award;
 - G. The Affidavit of Undertaking executed by **VIBAL**; and
 - H. Secretary's Certificate.
3. In consideration of the payments to be made by the **PRC**, **VIBAL** hereby agrees to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of this Contract.
