**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION THE AWARD OF CONTRACT FOR THE PROCUREMENT OF OFFICE SUPPLIES FOR CY 2017: LOT 3 – BOND PAPER SUBSTANCE 20 (8.5” x 13”) COMPATIBLE WITH PRC COLLATOR MACHINE DP DC -10/60 3710 TO NATION PAPER PRODUCTS & PRINTING CORPORATION WITH THE TOTAL BID AMOUNT OF ONE MILLION FOUR HUNDRED SIXTY FIVE THOUSAND FIVE HUNDRED TWENTY PESOS (Php1,465,520.00)**

**WHEREAS**, by the virtue of the invitation to apply for eligibility to bid through Public Bidding published in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPS), Purity Paper Inc. (Purity), Advance Paper Corporation (Advance) and Nation Paper Products and Printing Corporation (NAPPCO) participated for the project: Procurement of Office Supplies for CY 2017: Lot 3 – Bond Paper Substance 20 (8.5” x 13”) Compatible with PRC Collator Machine DP DC -10/60 3710 with an Approved Budget for the Contract of One Million Five Hundred Four Thousand Seven Hundred Seventy-Five Pesos (Php1,504,775.00) only.

**WHEREAS**, on February 17, 2017 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have which was attended by Advance Paper Corporation. However, there are already two bidders who purchased the Bid Documents namely: Purity Paper Inc. and Advance Paper Corporation.

**WHEREAS**, as a result of the discussion during the pre-bid conference, the Bids and Awards Committee (BAC) issued Bid Bulletin No.1 dated February 23, 2017 reflecting the modifications/amendments on the Technical Specifications in the bidding documents and rescheduling the opening of the bids from March 1, 2017 to March 6, 2017 at 10:00 A.M. The same was posted in PhilGeps and PRC website.

**WHEREAS**, on March 6, 2017, during the Opening of Bids, Purity, Advance and NAPPCO submitted their eligibility, technical and financial requirements and the sample of bond paper substance 20.

**WHEREAS**, Advance and NAPPCO having passed the eligibility and technical evaluation, the BAC opened their financial bid proposal.

**WHEREAS**, NAPPCO with a bid price of **ONE MILLION FOUR HUNDRED SIXTY FIVE THOUSAND FIVE HUNDRED TWENTY PESOS (Php1,465,520.00)** was declared as the Lowest Calculated Bidder and was subjected to post-qualification on March 17, 2017 at #34 Narciso St. East Canumay, Valenzuela City.

**WHEREAS**, NAPPCO passed the post-qualification, and was declared to be the Lowest Calculated and Responsive Bidder.


**WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it now RESOLVED,** to recommend to the Chairman of the Professional Regulation Commission, the award of contract for the Procurement of Office Supplies for CY 2017: Lot 3 – Bond Paper Substance 20 (8.5" x 13") Compatible with PRC Collator Machine DP DC -10/60 3710 to Nation Paper Products & Printing Corp. with the bid amount of **ONE MILLION FOUR HUNDRED SIXTY FIVE THOUSAND FIVE HUNDRED TWENTY PESOS (Php1,465,520.00)** only.
