RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION THE AWARD OF CONTRACT FOR THE PRINTING AND SHREDDING OF TEST BOOKLETS FOR THE SEPTEMBER 24, 2017 BOARD LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS TO VIBAL GROUP, INC. WITH THE TOTAL BID AMOUNT OF SIX MILLION FOUR HUNDRED SIXTY-SEVEN THOUSAND SIX HUNDRED THIRTY-EIGHT PESOS AND SEVENTY-SIX CENTAVOS (P6,467,638.76)

WHEREAS, by the virtue of the invitation to apply for eligibility to bid through Public Bidding published at the website of the Commission and the Philippine Government Electronic Procurement System (PhilGEPS), and at conspicuous places within the premises of the Commission, for the project "Printing and Shredding of Test Booklets for the March 26, 2017 and September 24, 2017 Board Licensure Examinations for Professional Teachers (BLEPT)", in compliance with Section 21.2 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184 (Government Procurement Reform Act).

WHEREAS, on February 16, 2017 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, and was attended by three (3) prospective bidders namely; Zurbano Publishing, Ernest Printing Corporation and Vibal Group, Inc. (Vibal). However, only Vibal purchased the Bid Documents.

WHEREAS, on February 28, 2017, during the Opening of Bids, Vibal submitted its eligibility, technical and financial requirements and the sample of gauge 3.

WHEREAS, Vibal having passed the eligibility and technical evaluation, the BAC opened its financial bid proposal with a bid price of **SIX MILLION FOUR HUNDRED SIXTY-SEVEN THOUSAND SIX HUNDRED THIRTY-EIGHT PESOS AND SEVENTY-SIX CENTAVOS (P6,467,638.76)**. Hence, Vibal was declared as the Single Calculated Bidder and was subjected to post-qualification on March 10, 2017 at 1253 G. Araneta Avenue, Quezon City.


WHEREAS, Vibal passed the post-qualification, and was declared to be the Single Calculated and Responsive Bidder.


WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it now **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, the award of contract for the Printing and Shredding of Test Booklets for the September 24, 2017 Board Licensure Examination for Professional Teachers to Vibal Group, Inc., with the Bid Amount of **SIX MILLION FOUR HUNDRED SIXTY-SEVEN THOUSAND SIX HUNDRED THIRTY-EIGHT PESOS AND SEVENTY-SIX CENTAVOS (P6,467,638.76)**.


