**FIXING THE TARGET DATE/S OF RELEASE OF EXAMINATION RESULTS  
OF THE VARIOUS PROFESSIONAL LICENSURE EXAMINATIONS INCLUDED IN  
THE APRIL 2023 SPECIAL PROFESSIONAL LICENSURE EXAMINATIONS**

**WHEREAS**, Section 7 (d) of Republic Act (R.A.) No. 8981, also known as the “PRC Modernization Act of 2000”, empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various Professional Regulatory Boards (Boards) in accordance with the rules and regulations it may promulgate; to determine and fix the places and dates of examinations; and to adopt measures to preserve the integrity and inviolability of the licensure examinations;

**WHEREAS**, Executive Order No. 835 (s. 2009) was issued directing the Commission and other government agencies through the Department of Labor and Employment (DOLE) to conduct yearly Special Professional Board Licensure Examinations (hereinafter referred to as Special Professional Licensure Examination (SPLE)), when so warranted, in the Kingdom of Saudi Arabia (KSA), Qatar, the United Arab Emirates (UAE) and other Middle East countries;

**WHEREAS**, in accordance with R.A. No. 8981, the Commission also conducts licensure examination in countries other than the Middle East;

**WHEREAS**, the Commission issued the following Resolutions relative to the conduct of the 2023 SPLE:

- **Resolution No. 1607 (s. 2023)** – *Fixing the Dates and Places of the 2023 Special Professional Licensure Examinations for Overseas Filipino Workers in the Middle East Countries and Singapore;*
- **Resolution No. 1612 (s. 2023)** – *Inclusion of the Certified Public Accountants, Physical Therapists and Real Estate Brokers Licensure Examinations in the April 2023 Special Professional Licensure Examinations in the Middle East and Singapore and Fixing the Deadline for the Filing of Applications Therefor; and*
- **Resolution No. 1618 (s. 2023)** – *Inclusion of the April 2023 Professional Mechanical Engineers Oral Examination/Technical Evaluation in the 2023 Special Professional Licensure Examinations;*

**WHEREAS**, there is a need to set the target date/s of release of examination results of the various professional licensure examinations included in the April 2023 SPLE;

**WHEREFORE**, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to fix the target date/s of release of examination results of the various professional licensure examinations included in the April 2023 SPLE as follows:
