**SCHEDULING THE FACE-TO-FACE ORAL EXAMINATION FOR
 PROFESSIONAL ELECTRONICS ENGINEERS**

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981, or the “PRC Modernization Act of 2000”, authorizes the Professional Regulation Commission (Commission) to determine and fix the places and dates of examinations;

WHEREAS, Section 7 (g) of R.A. No. 9292, or the “Electronics Engineering Law of 2004”, empowers the Professional Regulatory Board of Electronics Engineering (Board) to prescribe, amend or revise the requirements for licensing of Professional Electronics Engineers (PECE);

WHEREAS, Section 18, Article III of R.A No. 9292 provides that the Board shall schedule an *en banc* oral interview of the applicant for the PECE Oral Examination for the purpose of verifying, authenticating and assessing the submittals, and establishing the competency of the applicant according to the rules, regulations and competency standards to be formulated by the Board;

WHEREAS, the Board, during its meeting, has agreed to conduct a face-to-face PECE Oral Examination this month;

IN VIEW OF THE FOREGOING, the Board **RESOLVES**, as it is hereby **RESOLVED**, to schedule the Professional Electronics Engineers Oral Examination as follows:
