**CONDUCT OF COMPUTER-BASED LICENSURE EXAMINATION FOR THE
FEBRUARY 2024 SANITARY ENGINEERS LICENSURE EXAMINATION
AND REMOVAL OF BAGUIO AND DAVAO AS TESTING CENTERS**

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981, or the “PRC Modernization Act of 2000”, empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, Section 7 (q) of R.A. No. 8981 also empowers the Commission to fully computerize all licensure examinations given by the various Professional Regulatory Boards, and other operations of the Commission;

WHEREAS, pursuant to Resolution No. 1728 (s. 2023), the Sanitary Engineers Licensure Examination (SELE) is scheduled on February 27, 28 and 29, 2024 in the National Capital Region (NCR), Baguio, Davao, and Rosales;

WHEREAS, the modality of the conduct of the said licensure examination (LE) is computer-based in all testing centers mentioned above;

WHEREAS, PRC Cordillera Administrative Region (PRC-Baguio) requested the removal of Baguio as testing center as there is no facility yet to accommodate the computer-based LE;

WHEREAS, PRC-Baguio informed the affected examinees regarding their transfer to their preferred testing center, and that coordination with the available testing centers was done for their accommodation;

WHEREAS, due to low turnout of examinees, PRC Regional Office XI (PRC-Davao) informed the Commission of the same and requested the removal of Davao as testing center;

WHEREAS, PRC-Davao coordinated the transfer of its examinees to the PRC-NCR;

WHEREAS, the Professional Regulatory Board of Sanitary Engineering (Board) and the Licensure Office recommend to the Commission the conduct of full CBLE for Sanitary Engineers this February, as well as the removal of Baguio and Davao as testing centers;

WHEREFORE, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **CONDUCT full Computer-Based Licensure Examination (CBLE) for Sanitary Engineers on FEBRUARY 27, 28 AND 29, 2024.**

RESOLVED FURTHER, to **REMOVE BAGUIO** and **DAVAO** as testing centers, thus the Sanitary Engineers CBLE shall **PROCEED** as scheduled in **NCR** and **Rosales**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
