**RESCHEDULING THE SEPTEMBER 2024 PROFESSIONAL FORESTERS
 LICENSURE EXAMINATION TO OCTOBER 29 AND 30, 2024 AND
 EXTENDING THE DEADLINE FOR FILING OF APPLICATIONS
 FROM AUGUST 12, 2024 TO OCTOBER 15, 2024**

WHEREAS, Section 7(d) of Republic Act No. 8981, or the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1728 (s. 2023) scheduling the Professional Foresters Licensure Examination (PFLE) on September 12 and 13, 2024 in various testing centers and the deadline for filing of applications is on August 12, 2024;

WHEREAS, the Commission issued Resolution No. 1836 (s. 2024) revising the schedule of licensure examinations from August to December 2024 wherein the PFLE will be conducted specifically in the National Capital Region, Baguio, Cebu, and Davao;

WHEREAS, the Philippine Forestry Education Network, Inc. (PFEN) is requesting for the rescheduling of PFLE from September 2024 to October 2024 in order to align with the PFLE schedule in the previous years and also afford graduates from the June to August 2024 batches the opportunity to apply and take the licensure examination this year;

WHEREAS, the Professional Regulatory Board for Foresters and the Licensure Office recommend to the Commission the approval of the request to reschedule the dates of the examination and to extend the deadline for the filing of applications for the said licensure examination;

WHEREAS, the proposed rescheduling will enable the applicants ample time to prepare and submit their documentary requirements to the Commission.

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **RESCHEDULE** the **Professional Foresters Licensure Examination**, and to **EXTEND** the **Deadline for Filing of Applications**, to wit:
