**EXTENDING THE DEADLINE FOR THE FILING OF APPLICATION FOR THE
DECEMBER 2024 RADIOLOGIC TECHNOLOGISTS LICENSURE EXAMINATION
FROM NOVEMBER 13, 2024 TO NOVEMBER 20, 2024**

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981, or the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1728 (s. 2023) scheduling the Radiologic Technologists Licensure Examination (RTLE) on 12-13 December 2024 in various testing centers, with the deadline for filing of applications on 13 November 2024;

WHEREAS, the Commission issued Resolution No. 1836 (s. 2024) revising the schedule of licensure examinations from August to December 2024, wherein the RTLE will be conducted in the National Capital Region (NCR), Baguio, Cebu and Davao;

WHEREAS, the Commission issued Resolution No. 1891 (s. 2024) increasing the number of testing centers for the examinations scheduled from October to December 2024, designating the following as additional testing centers for the December 2024 RTLE: Butuan, Cagayan de Oro, Iloilo, Legazpi, Lucena, Pampanga, Rosales, Tacloban, Tuguegarao and Zamboanga;

WHEREAS, the Professional Regulatory Board of Radiologic Technology (Board) received requests from the schools/universities offering Radiologic Technology courses to extend the deadline for filing of application for the said licensure examination due to the delay in processing of the official Transcript of Records (TOR), particularly in the Bicol Region due to the devastation caused by Severe Tropical Storm "Kristine";

WHEREAS, the Board and the Licensure Office recommend to the Commission the approval of the request to extend the deadline for the filing of applications for the December 2024 RTLE;


WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **EXTEND** the **DEADLINE FOR FILING OF APPLICATION** for the **DECEMBER 2024 Radiologic Technologists Licensure Examination** from November 13, 2024 to **November 20, 2024**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
