RESOLUTION NO. 1922 Series of 2024

EXTENDING THE DEADLINE FOR THE FILING OF APPLICATION FOR THE DECEMBER 2024 OCCUPATIONAL THERAPISTS LICENSURE EXAMINATION FROM NOVEMBER 14, 2024 TO NOVEMBER 22, 2024

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981, or the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1728 (s. 2023) scheduling the Occupational Therapists Licensure Examination (OTLE) on 14-15 December 2024 in various testing centers, with the deadline for filing of applications on 14 November 2024;

WHEREAS, the Commission issued Resolution No. 1836 (s. 2024) revising the schedule of licensure examinations from August to December 2024, wherein the OTLE will be conducted specifically in the National Capital Region (NCR) only;

WHEREAS, the Commission issued Resolution No. 1891 (s. 2024) increasing the number of testing centers for the examinations scheduled from October to December 2024, designating the following as testing centers for the December 2024 OTLE: NCR, Cebu, Davao, Iloilo, Legazpi, Pampanga, and Rosales;

WHEREAS, the Interim Professional Regulatory Board of Occupational Therapy (Board) received requests from examinees to extend the deadline for filing of application for the said licensure examination due to the delay in processing of their official Transcript of Records (TOR), and Certification, Authentication and Verification (CAV) as requirements needed per the new *Occupational Therapy Law*;

WHEREAS, the Board and the Licensure Office recommend to the Commission the approval of the request to extend the deadline for the filing of applications for the December 2024 OTLE;

WHEREAS, the proposed rescheduling will give the examinees ample time to prepare and submit their documentary requirements to the Commission.

WHEREFORE, the Commission RESOLVES, as it is hereby RESOLVED, to EXTEND the DEADLINE FOR FILING OF APPLICATION for the DECEMBER 2024 Occupational Therapists Licensure Examination from November 14, 2024 to November 22, 2024.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
