**REMOVING CAGAYAN DE ORO AS A TESTING CENTER FOR THE  
FEBRUARY 2025 SANITARY ENGINEERS LICENSURE EXAMINATION**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981, or the “PRC Modernization Act of 2000”, empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

**WHEREAS**, the Commission issued Resolution No. 1927 (s. 2024) scheduling the Sanitary Engineers Licensure Examination (SELE) on February 26, 27 and 28, 2025 in testing centers nationwide;

**WHEREAS**, the Commission issued Memorandum Order No. 35 (s. 2024) allowing the PRC Regional Offices to request for cancellation of the conduct of a licensure examination in previously designated testing centers if there are less than fifty (50) examinees who applied thereat;

**WHEREAS**, Cagayan de Oro is one of the designated testing centers for the February 2025 SELE;

**WHEREAS**, there is only one (1) examinee who applied in Cagayan De Oro for the said licensure examination;

**WHEREAS**, due to the low turnout of examinees, PRC Regional Office X (PRC Cagayan de Oro) requested to cancel the scheduled licensure examination in the said area;

**WHEREAS**, the Professional Regulatory Board of Sanitary Engineering and the Licensure Office recommend to the Commission the cancellation of the conduct of the February 2025 SELE in Cagayan de Oro;

**WHEREFORE**, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **REMOVE CAGAYAN DE ORO** as a testing center in the conduct of the **February 2025 Sanitary Engineers Licensure Examination**.

The PRC Regional Office X (Cagayan de Oro) shall assist the affected examinee in transferring to other testing center where he/she opt to take the examination.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
