ADDITIONAL SCHEDULE FOR THE CONDUCT OF COMPUTER-BASED LICENSURE EXAMINATION FOR SPEECH-LANGUAGE PATHOLOGISTS ON MAY 18-19, 2025 AND DESIGNATING THE NATIONAL CAPITAL REGION AS TESTING CENTER THEREOF

WHEREAS, Section 7 (d) of Republic Act No. 8981, or the “PRC Modernization Act of 2000”, empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and **fix the places and dates of examinations**;

WHEREAS, Section 7 (q) of R.A. No. 8981 also empowers the Commission to fully computerize all licensure examinations given by the various Professional Regulatory Boards and other operations of the Commission;

WHEREAS, the Commission issued Resolution No. 1927 (s. 2024) scheduling the Speech-Language Pathologists Licensure Examination (SLPLE) on November 13 to 14, 2025 in the National Capital Region (NCR), Cagayan de Oro, Davao and Lucena;

WHEREAS, the Professional Regulatory Board of Speech-Language Pathology (Board) received requests for an additional schedule of SLPLE;

WHEREAS, there are thirty (30) prospective examinees who may apply and take the said licensure examination;

WHEREAS, the said SLPLE shall be conducted in NCR only, which is Computer-Based Licensure Examination (CBLE)-ready, for easy and smooth monitoring in the administration and conduct of the same;

WHEREAS, the Board finds the justifications for the request acceptable, namely, (1) it will allow graduates and re-takers to take the SLPLE the soonest time possible; (2) there is dearth of SLPs in the country; and (3) additional practitioners will improve and increase the marginalized population’s access to SLP services;

WHEREAS, the Board and the Licensure Office recommend to the Commission the additional examination schedule for the conduct of CBLE for SLP this year.

WHEREFORE, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to have an additional examination schedule for the conduct of the **COMPUTER-BASED LICENSURE EXAMINATION FOR SPEECH-LANGUAGE PATHOLOGISTS**, to wit:
