RESOLUTION NO. 1976 Series of 2025

SCHEDULE OF THE JUNE 2025 SPECIAL PROFESSIONAL LICENSURE EXAMINATIONS PER PROFESSION IN THE MIDDLE EAST COUNTRIES, SINGAPORE AND TAIWAN

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981, also known as the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various Professional Regulatory Boards (PRBs) in accordance with the rules and regulations it may promulgate, determine and fix the places and dates of examinations, and adopt measures to preserve the integrity and inviolability of the licensure examinations;

WHEREAS, Executive Order No. 835 dated October 6, 2009 was issued directing the Commission and other government agencies, through the Department of Labor and Employment, to conduct yearly Special Professional Board Licensure Examinations [hereinafter referred to as "Special Professional Licensure Examination" (SPLE)], when so warranted, in the Kingdom of Saudi Arabia (KSA), Qatar, the United Arab Emirates (UAE), and other Middle East countries;

WHEREAS, in accordance with R.A. No. 8981, the Commission also conducts licensure examination in countries other than the Middle East:

WHEREAS, the Commission issued Resolution No. 1962 (s. 2025) fixing the dates and places of the 2025 SPLE for Overseas Filipino Workers (OFWs) in the Middle East countries, Singapore and Taiwan;

WHEREAS, it is deemed proper to set the three (3)-day program of various professions for the June 2025 SPLE for the guidance of PRBs, examinees, SPLE Teams, examination personnel and stakeholders;

WHEREFORE, the Commission RESOLVES, as it is hereby RESOLVED, to fix the date/s of licensure examinations for the June 2025 SPLE, to wit:
