**REMOVING TACLOBAN AND PAGADIAN AS TESTING CENTERS FOR THE  
APRIL 2025 ELECTRONICS ENGINEERS AND ELECTRONICS TECHNICIANS  
LICENSURE EXAMINATIONS**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981, or the “PRC Modernization Act of 2000”, empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

**WHEREAS**, the Commission issued Resolution No. 1927 (s. 2024) scheduling the Electronics Engineers Licensure Examination (EELE) on April 02 and 03, 2025 and Electronics Technicians Licensure Examination (ECTLE) on April 04, 2025 in various testing centers;

**WHEREAS**, the Commission issued Memorandum Order No. 35 (s. 2024) allowing the PRC Regional Offices to request for cancellation of the conduct of a licensure examination in previously designated testing centers if there are less than fifty (50) examinees who applied thereat;

**WHEREAS**, Tacloban and Pagadian are designated testing centers for the April 2025 EELE and ECTLE;

**WHEREAS**, there are only three (3) examinees who applied in Tacloban, while only two (2) examinees applied in Pagadian for the April 2025 EELE;

**WHEREAS**, there are only three (3) examinees who applied in Tacloban, while no examinee applied in Pagadian for the April 2025 ECTLE;

**WHEREAS**, due to the low turnout of examinees, it is deemed more prudent not to proceed with the scheduled licensure examinations in the said areas;

**WHEREAS**, the Professional Regulatory Board of Electronics Engineering and the Licensure Office recommend to the Commission the cancellation of the conduct of the April 2025 EELE and ECTLE in Tacloban and Pagadian;

**WHEREFORE**, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **REMOVE TACLOBAN AND PAGADIAN** as testing centers for the **April 2025 Electronics Engineers and Electronics Technicians Licensure Examinations**.

The PRC Regional Offices VIII and IX shall assist the affected examinees in transferring to other testing centers where they opt to take the said examinations.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examinations.
