 - 2. Report to the school/building assignment before 5:30 a.m. on the first day of examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
 - 3. <u>ALL EXAMINEES ARE REQUIRED TO WEAR THEIR RESPECTIVE COLLEGE</u> <u>UNIFORM per Resolution No. 311 dated May 18, 1994.</u>
 - 4. Bring the following on examination day:
 - a. Notice of Admission
 - b. Official Receipt
 - c. Two (2) or more pencils (No. 2)
 - d. Ball pens with **BLACK ink only**
 - e. One (1) piece long brown envelope
 - f. One (1) piece Long Transparent (non-colored) Plastic Envelope (for keeping your valuables and other allowed items).
 - 5. The following are **STRICTLY PROHIBITED** inside the examination premises/rooms:
 - a. Books, notes, review materials, and other materials containing coded data/ information/ formula.
 - b. ALL KINDS OF CALCULATORS
 - c. APPLE, SAMSUNG AND OTHER SMARTWATCHES, CELLULAR PHONES, EARPLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSE.
 - d. Bags of any kind (ladies bag, shoulder bags, attaché case, backpacks, etc.)
 - e. Other examination aides not stated in this program.

The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57, s. 2020) shall be strictly observed.
