Licensure Examination for Master Plumbers in Koronadal City (February 20-21, 2025)

The Professional Regulation Commission - Regional Office XII hereby informs the examinees of the February 2025 Master Plumbers' Licensure Examination in KORONADAL CITY of the following guidelines:

Venue of the Examination:

- Mary Mount School of Koronadal, Inc. - Crisologo St., Baldostamon Village, Brgy. Zone Iv, Koronadal City

Required items/ documents during examination days

1. Official Receipt
2. Notice of Admission
3. Ball pens with BLACK ink only
4. Two (2) or more Pencils (No. 2)
5. One (1) piece long brown envelope
6. One (1) piece long transparent/plastic envelope (for keeping valuables and other allowed items)
7. NON-PROGRAMMABLE CALCULATORS (Please refer to Commission Resolution No. 1809-2024 or the "Updated List of Non-Programmable Calculators Allowed to be used in the Licensure Examinations")

NOTE: ONLY ONE BASIC CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM PER EXAMINEE. CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET BEFORE THE START OF THE EXAMINATION.

Prohibited items inside the examination premises/ rooms

1. Books, notes, review materials, and all other printed materials containing coded data/ information/ formulas.
2. Calculators that are programmable or with embedded functions, especially CASIO FX991ES and CASIO FX-991ES plus.
3. Mobile phones, smart watches such as Apple, Samsung, or other brands, earplugs, transmitters, portable computers, Bluetooth, and other electronic gadgets/devices that may be used to store or retrieve data/ information or to communicate for whatever purposes.
4. Bags of any kind (ladies' bag, shoulder bags, attaché case, backpacks, etc.)
5. Other examination aides not stated in the board program.

What to wear every examination day

Examinees are required to wear the following attire every examination day:

Male Examinees - White polo shirt or shirts with a collar, tucked-in (without any seal, logo, or mark) Decent pants or slacks

Female Examinees - White blouse or shirt with collar (without any seal, logo, or mark) Decent pants, slacks, or skirts

General instructions to the examinees

1. Check or verify your school assignment at the PRC official website (www.prc.gov.ph) two (2) to three (3) working days before the examination. You may visit your school assignment before the day of the examination.
2. Report to your school assignment before 5:30 A.M on the first day of examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
3. All personal belongings of the examinees shall be surrendered to the proctor and placed in a secured space within the examination room.
NOTE: PERSONAL BELONGINGS BROUGHT BY AN EXAMINEE SHALL BE FOR HIS/HER ACCOUNT. THE PRC WILL NOT BE ANSWERABLE FOR ANY SUCH ITEM OR PERSONAL BELONGING THAT MIGHT BE LOST DURING THE EXAM WITHOUT FAULT OR NEGLIGENCE ON ITS PART.
4. Loitering and unnecessary conversing in the hallways or the examination rooms are STRICTLY PROHIBITED.
5. Examinees shall bring their prepacked meals/ snacks and water/drink upon entry to the examination room, which shall be eaten on their assigned seats. Food deliveries are NOT allowed during the examination.
6. Use of polyethylene terephthalate (PET) bottles, plastic wrappers, and food packages shall be avoided in observance of the city's solid waste management initiatives. Litters must be disposed of properly in the designated garbage bins.
7. Read carefully and follow the instructions on your NOTICE OF ADMISSION and EXAMINEES GUIDE.
8. Cheating and all other prohibited acts as stipulated in Memorandum Order No. 57, series of 2020, which will impair the integrity and credibility of the licensure examination shall be dealt with accordingly.
