 - Lot 1 – Supply and Delivery of Pre-Printed ASEAN ID Cards with Approved Budget of the Contract of Four Hundred Forty-Seven Thousand Eight Hundred Pesos (Php447,800.00) - (ITB No. 2023 – 53)
 - Lot 2 – Supply and Delivery of Pre-Printed STP ID Cards with Approved Budget of the Contract of Two Hundred Forty-Three Thousand Seventy-Five Pesos (Php243,075.00) - (ITB No. 2023 – 54)

2. Item 5.3 of Section III. Bid Data Sheet shall now read as follows:

5.3	<p>For this purpose, contracts similar to the Project shall be:</p> <ol style="list-style-type: none"> a. Similar contracts shall refer to contracts for Procurement of Materials and/or Consumables with paired IT Equipment for the Pre-printed ID Cards. b. The Bidder must have completed a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC within the period from January 2019 prior to the deadline for the submission and receipt of bids.

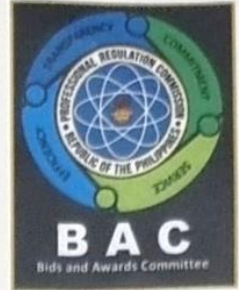

Certification must be submitted during contract of implementation. Negative results from DOST shall merit revocation or termination of the Contract.
Lot 2	<p><u>Additional Requirements</u></p> <ul style="list-style-type: none"> Certification of the results of test from the Department of Science and Technology (DOST) as to the thickness of the card such as: (100% PVC (PolyvinylChloride); International Credit Card Standard (CR-80); Thickness: 0.76 mm. Certification must be submitted during contract of implementation. Negative results from DOST shall merit revocation or termination of the Contract. <p><u>Consumables:</u></p> <ul style="list-style-type: none"> Ribbons: Thirteen (13) Rolls <p>Must be able to print at least two thousand five hundred (2,500) pieces of STP ID Cards, and must be compatible with the card printing equipment.</p> <ul style="list-style-type: none"> ➤ Five (5) panel color ribbon ➤ Testing of ribbon printing capacity will be conducted during the post qualification. ➤ Supplier shall provide 10% of the stated number of ribbon as buffer with no additional cost to PRC; ➤ In case of deficiency on the number of ribbons, the concerned regional office may be allowed to purchase from the same supplier using their respective budget with the same price as stated in the contract.
