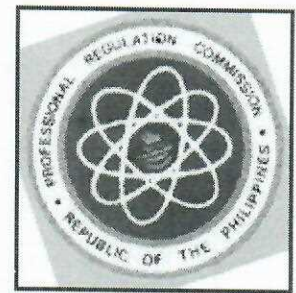

### PROJECT: PROCUREMENT OF ONE (1) YEAR SUBSCRIPTION OF ANTIVIRUS FOR 900 USERS

Please be advised of the following modifications/amendments to the Bidding Documents.

#### 1. Section III. Bid Data Sheet shall now read as follows:

5.4	The Bidder must have completed, within the period specified in the Invitation to Bid and <b>ITB Clause 12.1 a (ii)</b> , a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC.  For this purpose, similar contracts shall refer to contracts for the <b>Procurement of One (1) Year Subscription of Antivirus for 900 Users.</b>  Note: <i>Contracts pertaining to Desktops and Laptops bundled with Subscription of Antivirus may be accepted provided that the duration of the subscription shall not be less than one year.</i>
12.1(a) (ii)	The bidder's Single Largest Completed Contract ( <b>SLCC</b> ) similar to the contract to be bid should have been completed within <b>January 2008</b> prior to the date of the submission and receipt of bids.  Note: <i>Contracts pertaining to Desktops and Laptops bundled with subscription of Antivirus may be accepted provided that the duration of the Subscription shall not be less than one year.</i>
29.2 (a)	<b>Only tax returns filed and taxes paid through the BIR Electronic Filing and Payment System (EFPS) shall be accepted.</b>  Note: <i>The latest income and business tax returns shall refer to the 2<sup>nd</sup> and 3<sup>rd</sup> Quarter of year 2018.</i>
