**WHEREAS**, Republic Act (RA) No. 10912, also known as “An Act Mandating and Strengthening the Continuing Professional Development Program for all Registered Professions, Creating the Continuing Professional Development Council and Appropriating Funds Therefor, and for Other Related Purpose”, lapsed into law on July 21, 2016;

**WHEREAS**, Section 7 of R.A. No. 10912 and Section 7 of PRC Resolution No. 1032, (s 2017) provide for the composition of the CPD Council, namely: the Chairperson from the PRB concerned; First (1<sup>st</sup>) Member from the Accredited Professional Organization/Accredited Integrated Professional Organization (APO/AIPO); and Second (2<sup>nd</sup>) Member from the national organization of deans or department heads of schools colleges or universities offering any course requiring the licensure examination;

**WHEREAS**, it is further provided that in the absence of the representative from the organization of deans or department heads, the Board shall submit to the Commission within ten (10) working days from notification of such absence, a list of three (3) recommendees from the APO/AIPO:


**WHEREAS**, there is, at present, the accreditation of Philippine Dental Association, Inc. (PDA) is expired and no recognized or established Accredited Professional Organization/Accredited Integrated Professional Organization (APO/AIPO) for Dentists, Dental Technologists and Dental Hygienists.
