**ADOPTION, ISSUANCE, AND PROMULGATION OF THE ENHANCED
TABLES OF SPECIFICATIONS FOR THE SUBJECTS IN THE
ELECTRONICS ENGINEERS LICENSURE EXAMINATION**

WHEREAS, Section 9 (h) of Republic Act (R.A.) No. 8981, known as the “PRC Modernization Act of 2000” empowers the Professional Regulatory Boards to prepare, adopt, and issue the syllabi or *tables of specifications* (TOS) of the subjects for examinations in consultation with the academe, and determine and prepare the questions for the licensure examinations which shall strictly be within the scope of the syllabus or TOS of the subject for examination;

WHEREAS, the Professional Regulatory Board of Electronics Engineering (Board) issued Resolution No. 06 (s. 2012) on the promulgation of the syllabi or TOS for the subjects in the Electronics Engineers Licensure Examinations (EELE);

WHEREAS, the TOS shall be the basis for the test items to be encoded into the Test Questions Databank System;

WHEREAS, the TOS shall include the competencies covering the topics and subtopics, the percentage weights, and number of items, as well as the levels of difficulty classified as follows: Easy (Remembering and Understanding), Moderate (Applying and Analyzing), and Difficult (Evaluating and Creating);

WHEREAS, the TOS shall further include the qualifications level descriptors defined in terms of knowledge, skills and values, application, and degree of independence referred to in Section 8 of R.A. No. 10968 or the “PQF Act”;

WHEREAS, the Board conducted a public consultation, in partnership with the Institute of Electronics Engineers of the Philippines, in compliance with R.A. No. 8981;

WHEREAS, the Board, with the guidance of the PRC Consultant for Test Construction and Development, formulated the TOS for implementation in the EELE.

NOW THEREFORE, the Board **RESOLVES**, as it is hereby **RESOLVED**, to adopt, issue, and promulgate the “Enhanced Tables of Specifications for the subjects in the Electronics Engineers Licensure Examinations”, marked as Annex “A” and made an integral part of this Resolution.

RESOLVED FURTHER, that this Resolution shall apply in the October 2022 EELE and the subsequent schedules thereof.

This supersedes Resolution No. 06 (s. 2012), entitled “Promulgation of the Syllabi or Tables of Specification (TOS) for the Subjects in the Board Licensure Examination for Electronics Engineers”.

This Resolution shall take effect immediately following the completion of its publication in the Official Gazette or in any newspaper of general circulation in the Philippines, copy furnished the University of the Philippines Law Center.
