- 6. One (1) piece long size Brown Envelope
- 7. One (1) piece long size Transparent (non-colored) Plastic Envelope (for keeping your valuables)
- 8. Two (2) or more pencils (No. 2)
- 9. Pens with **BLACK** ink only
- 10. Only **one (1) Basic calculator** shall be allowed inside the examination room which shall be inspected and have to be reset before the start of the examination.

Note: Above materials shall be placed inside a transparent cellophane or bag.

#### PRESCRIBED DRESS CODE:

- a) Male examinee Any scrub suit/ white polo shirt with collar (without any seal, logo or mark), tucked-in decent pants or slacks.
- b) **Female examinee** Any scrub suit/ white blouses or shirts with collar (without any seal, logo or mark), tucked-in decent skirts or slacks, pony-tailed long hair.
