Licensure Examination for Criminologists in Koronadal City (July 31- August 02, 2024)

The Professional Regulation Commission - Regional Office XII hereby informs all the concerned examinees of the aforesaid licensure examination in **KORONADAL CITY** of the following important guidelines:

Venues of the Examination

- ❖ *Ramon Magsaysay Memorial Colleges Marbel Inc. (New Building)- Prk. Waling-waling Arellano St., Brgy. Zone II, Koronadal City*
- ❖ *Korbel Foundation College, Inc.- Purok Spring Uno, Brgy. Morales, Koronadal City*
- ❖ *Notre Dame of Marbel University-Alunan Avenue, Koronadal City*

Documentary requirements to be presented on the first day of examination

1. Notice of Admission (NOA)
2. Official Receipt

Required items for the examination

1. Two (2) or more pencils (No. 2)
2. Pens with **BLACK** ink only
3. One (1) piece long brown envelope
4. One (1) piece long transparent (non-colored) plastic envelope (*for keeping valuables and other allowed items*)
5. HORSESHOE MICROSCOPE OR MAGNIFYING GLASS

PROHIBITED items inside the examination premises/ rooms

1. Books, notes, review materials, and all other printed materials containing coded data/ information/ formulas
2. ALL KINDS OF CALCULATORS
3. Mobile phones, smart watches such as Apple, Samsung, or other brands, earplugs, transmitters, portable computers, Bluetooth, and other electronic gadgets/devices that may be used to store or retrieve data/ information and/ or to communicate for whatever purposes.
4. Bags of any kind (ladies' bag, shoulder bags, attaché case, backpacks, etc.)
5. Other examination aides not stated in the board program.

General Instructions to the Examinees

1. Check or verify your school assignment at the PRC official website (www.prc.gov.ph) two (2) to three (3) working days before the examination. Bring your NOTICE OF ADMISSION when you verify your school assignment. Visit your school assignment before the day of the examination.
2. Report to the school assignment before 5:30 AM on the first day of the examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
3. Examinees are required to wear the following attire every examination day:
 - **Male Examinees** - Tucked-in white polo shirt with collar (without any seal, logo, or mark), decent pants or slacks
 - **Female Examinees** - Tucked-in white blouse or shirt with collar (without any seal, logo, or mark), decent pants, slacks, or skirt, pony-tailed long hair
4. Personal belongings shall be surrendered to the proctor and shall be placed in a secured space within the examination room.
5. Loitering and unnecessary conversing in the hallways or the examination rooms are **STRICTLY PROHIBITED**.
6. Examinees shall bring their prepacked meals/ snacks and drinks upon entry to the examination room, which shall be eaten on their assigned seats. **Food deliveries are NOT allowed during the examination.**
7. Use of polyethylene terephthalate (PET) bottles, plastic wrappers, and food packages shall be avoided in observance of the solid waste management initiatives of the city and the partner schools. Litters must be disposed of properly in the designated garbage bins.
8. Cheating and all other forms of prohibited acts as stipulated in Memorandum Order No. 57, series of 2020, which will impair the integrity and credibility of the licensure examination shall be dealt with accordingly.
