	<p>All envelopes shall:</p> <ol style="list-style-type: none"> <li>contain the name of the contract to be bid in capital letters;</li> <li>bear the name and address of the Bidder in capital letters;</li> <li>be addressed to the Procuring Entity's BAC in accordance with <b>ITB</b> Clause 1.1;</li> <li>bear the specific identification of this bidding process indicated in the <b>ITB</b> Clause 1; and</li> <li>bear a warning "DO NOT OPEN BEFORE..." the date and time for the opening of bids, in accordance with <b>ITB</b> Clause 16.</li> </ol> <p>Bid envelopes that are not properly sealed and marked, as required in the bidding documents, shall not be rejected, but the Bidder or its duly authorized representative shall acknowledge such condition of the bid as submitted.
