7. OTHERS

7.1. Training

As part of the virtualization implementation, PRC would like to ensure that training is provided to key personnel involved in supporting the virtual environment and the use of its features.

7.1.1. Following the successful completion of the project, the vendor is required to provide a minimum of 10 days of on-site training on the proper configuration, daily operation, and maintenance of the system

7.1.2. The training will be for individuals who work directly for the ICT Service. The vendor will provide a minimum of 2 copies of all installation, configuration, and/or training materials. This includes any and all materials offered by the vendor deemed to be helpful in the day to day operations and management of the system.

7.2. Maintenance and Support

Following the successful completion of the project, the vendor is required to provide the following support information regarding technical support and other vendor services.

7.2.1. 1-year on-site support with 24 x 7 coverage and 4-hour response time.

7.2.2. Lead technical person should be a Manufacturer Certified Professional.

7.2.3. Materials describing the process for reporting a hardware and or software failure in any of the components of the proposed system.

7.2.4. The methods available for contacting tech support (phone, email, website, etc.) including escalation procedures.

7.2.5. Standard warranty and maintenance for each of the components proposed.

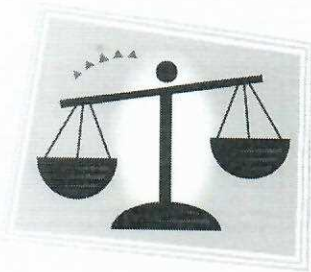
7.2.6. Upgrade path for management software and any annual support fee for the software.

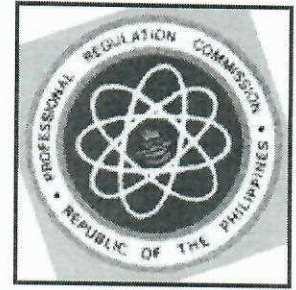

7.3.1.2. **EXECUTIVE SUMMARY REPORT.** A document developed to summarize the scope, approach, and results, in a manner suitable for senior management.

1. Compliance with the statements must be supported by evidence in a Bidders Bid and cross-referenced to that evidence.
