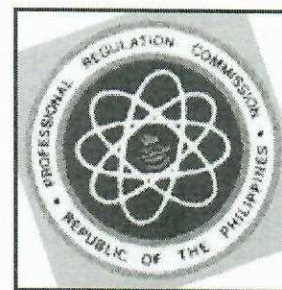

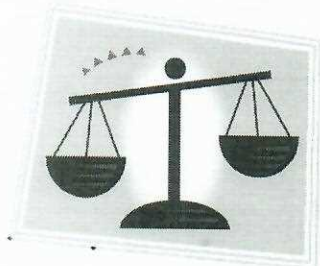

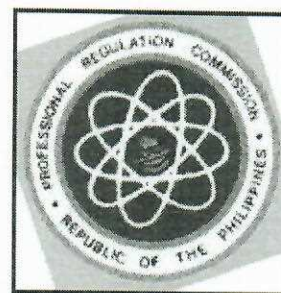

1.1	The Procuring Entity is the <i>Professional Regulation Commission</i>
1.2	The name of the Project is <b>Procurement of Internet and IP VPN Connectivity &amp; Upgrade with Network Live Access for CY 2019 with a Total Approved Budget for the Contract (ABC) of Fourteen Million Three Hundred Twenty Thousand Pesos (Php14,320,000.00).</b> The identification or reference number of the Contract is: <b>ITB No. 2019-15</b>
2	The Funding Source is the Government of the Philippines (GOP) through the <i>General Appropriations Act of 2019.</i>
5.1	Bidding is restricted to eligible bidders as provided by ITB clause 5.1
5.2	None of the circumstances mentioned in the <b>ITB</b> Clause exists in this Project. Foreign bidders, except those falling under <b>ITB</b> Clause 5.2 (b), may not participate in this Project.
5.4	The Bidder must have completed, within the period specified in the Invitation to Bid and <b>ITB</b> Clause 12.1 a (ii), a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC. For this purpose, similar contracts shall refer to <i>contracts for the Procurement of Internet and IP VPN Connectivity &amp; Upgrade with Network Live Access.</i>
5.5	<b>The Bidder must submit a computation of its Net Financial Contracting Capacity (NFCC), which must be at least equal to the ABC to be bid, calculated as follows:</b>  NFCC = [(Current assets minus current liabilities) (15)] minus the value of all outstanding or uncompleted portions of the projects under going contracts, including awarded contracts yet to be started coinciding with the contract for this Project.  The values of the domestic bidder's current assets and current liabilities shall be based on the latest Audited Financial Statements submitted to the BIR- for purposes of computing the foreign bidders' NFCC, the value of the current assets and current liabilities shall be based on their Audited Financial Statement prepared in accordance with international financial reporting standards.

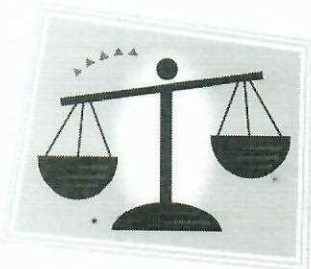

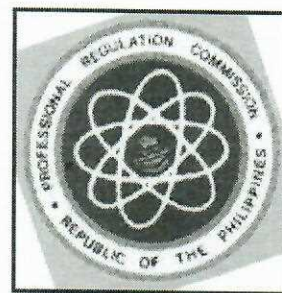

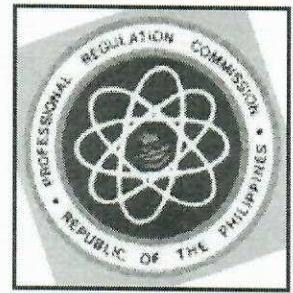
13.2 (a)	The ABC is <b>FOURTEEN MILLION, THREE HUNDRED TWENTY THOUSAND PESOS (Php14,320,000.00)</b> , inclusive of all taxes and bank charges.  Any bid with a financial component exceeding this amount shall not be accepted and will be disqualified.
15.4 (a) (iii)	"No incidental services are required."
15.4 (b) (i)	Maintain the ITB Clause and state here "Not applicable", "The price of the Goods shall be quoted DDP [state place of destination]", or the applicable INCOTERMS for this Project.
15.4 (b) (ii)	List here the incidental services that are required as part of the Bidder's bid cross referencing to the technical specifications and SCC as appropriate. If none, state "No incidental services are required."

Submission of bids that contain false information or falsified documents, or the concealment of such information in the bids in order to influence the outcome of eligibility screening or any other stage of the public bidding. 3. Allowing the use of one's name, or using the name of another for purposes of public bidding. 4. Withdrawal of a bid, or refusal to accept an award, or enter into contract with the Government without justifiable cause, after the Bidder had been adjudged as having submitted the Lowest Calculated and Responsive Bid. 5. Refusal or failure to post the required performance security within the prescribed time. 6. Refusal to clarify or validate in writing its bid during post-qualification within a period of seven (7) calendar days from receipt of the request for clarification. 7. Any documented unsolicited attempt by a bidder to unduly influence the outcome of the bidding in his favor. 8. Failure of the potential joint venture partners to enter into the joint venture after the bid is declared as successful. 9. All other acts that tend to defeat the purpose of the competitive bidding, such as habitually withdrawing from bidding, submitting late Bids or patently insufficient bid, for at least three (3) times within a year, except for valid reasons.
