GENERAL INSTRUCTIONS TO LEPT EXAMINEES

1. The **NOTICE OF ADMISSION** will be issued at the POLO/testing centers.
2. Please bring original documents with you for final evaluation and four (4) pieces passport size pictures with name tag.
3. Bring the following on examination day:
 - a. Notice of Admission
 - b. Two (2) or more pencils (No. 1 or 2)
 - c. Ballpens with **BLACK ink only**
 - d. One piece long brown envelope
 - e. One piece long transparent/plastic envelope
4. The following are **STRICTLY PROHIBITED** inside the examination premises/rooms:
 - a. Books, notes, review materials, and other materials containing coded data/information/ formula;

- b. **For LEPT Elementary Level-** ALL KINDS OF CALCULATOR
For LEPT Secondary Level- ALL KINDS OF CALCULATOR EXCEPT FOR
THOSE WITH MATHEMATICS MAJOR PURSUANT TO COMMISSION
RESOLUTION NO. 1809-2024.

**ONLY ONE CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION
ROOM. ALL CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET
BEFORE THE START OF THE EXAMINATION.**

- c. **APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR
PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER
ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO STORE OR
RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER
PURPOSES;**
- d. Bags of any kind (ladies bags, shoulder bags, attache case, backpacks, etc.)
- e. Other examination aids not stated in this program.
