**APPROVAL OF APPLICATIONS FOR REGISTRATION WITHOUT EXAMINATION
AS MEDICAL LABORATORY TECHNICIANS**

WHEREAS, Section 21(3)¹ of Republic Act (R.A.) No. 5527, also known as the “Philippine Medical Technology Act of 1969”, as amended, states that the Professional Regulatory Board of Medical Technology (Board) shall issue a certificate of registration without examination as medical laboratory technician, subject to compliance with the conditions therein prescribed;

WHEREAS, the Professional Regulation Commission (Commission) issued Memorandum Order No. 01 (s. 2020) on the “Revised Guidelines on Transmittal and Action of ‘For the Board’ (FTB) application documents from the Regional Offices”;

WHEREAS, for consideration of the Board are below applicants for registration without examination as Medical Laboratory Technicians in accordance with Section 21(3) of R.A. No. 5527, as amended:
