**WHEREAS,** Section 21(3)¹ of Republic Act (RA) No. 5527, also known as the "Philippine Medical Technology Act of 1969", as amended, states that the Professional Regulatory Board of Medical Technology (Board) shall issue a certificate of registration as medical laboratory technician without examination; subject to compliance with the conditions therein prescribed;
