**DESIGNATING LUCENA CITY AS ADDITIONAL TESTING CENTER FOR THE
OCTOBER 2021 CHEMICAL ENGINEERS LICENSURE EXAMINATION**

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, pursuant to Resolution No. 1283 (s. 2020), the schedules for the Chemical Engineers Licensure Examination (ChELE) are on May 11, 12 & 13, 2021 and October 2, 3 & 4, 2021;

WHEREAS, Resolution No. 1342 (s. 2021) was issued postponing the May 2021 ChELE and rescheduling the same to October 3, 4 & 5, 2021;

WHEREAS, the Philippine Institute of Chemical Engineers (PChE) – Laguna Chapter requested to include Lucena City as an additional testing center for the conduct of the 2021 ChELE;

WHEREAS, Officer-In-Charge-Director Renaldo V. Cristobal of PRC Lucena supports the said request and endorses the same to the Commission for approval;

WHEREAS, in view of the health measures imposed by the national government to mitigate, if not contain, the spread of COVID-19 through, but not limited to, social distancing and travel restrictions from one place to another, the Professional Regulatory Board of Chemical Engineering endorsed the approval of the above request for the welfare of the prospective examinees from the said city by allowing them to take the ChELE without unnecessary distant travel and additional expenses;

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to designate Lucena City as additional testing center for the October 2021 Chemical Engineers Licensure Examination;

RESOLVED FURTHER, that those interested examinees who are registered in the May 2020, October 2020 and May 2021 CheLE may change their original place of exam to **LUCENA on or before September 24, 2021** for facilitation of the final list of examinees for room assignment;

RESOLVED FINALLY, that necessary coordination be undertaken by the appropriate offices/divisions of the Commission to ensure the smooth and orderly conduct of said licensure examination in this testing center.
