RESOLUTION NO. 1503

**REMOVING CAUAYAN CITY, TUGUEGARAO CITY, KIDAPAWAN CITY AND
CATANDUANES AS TESTING CENTERS IN THE JUNE 2022 LICENSURE
EXAMINATION FOR PROFESSIONAL TEACHERS**

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1439 (s. 2021) scheduling the Licensure Examination for Professional Teachers (LEPT) on 30 January 2022, 27 March 2022, 26 June 2022, and 25 September 2022, in different regions nationwide;

WHEREAS, PRC-Region II (PRC-Tuguegarao) requested to cancel the June 2022 LEPT in Cauayan City and Tuguegarao City since there is only one (1) applicant in each testing center;

WHEREAS, the PRC-Region V (PRC-Legazpi) and PRC-Region XII (PRC-Koronadal) requested to cancel the June 2022 LEPT in Catanduanes (no applicant), and Kidapawan City (five (5) applicants only), respectively;

WHEREAS, to assist the affected examinees, PRC-Tuguegarao and PRC-Koronadal advised the examinees to consider transferring to other testing centers;

WHEREAS, upon these considerations, it has been recommended by the Professional Regulatory Board for Professional Teachers and the Licensure Office to cancel the conduct of the June 2022 LEPT in Cauayan City, Tuguegarao City, Kidapawan City and Catanduanes.

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to adopt the recommendation to **REMOVE CAUAYAN CITY, TUGUEGARAO CITY, KIDAPAWAN CITY** and **CATANDUANES** as testing centers for the June 2022 Licensure Examination for Professional Teachers.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
