**TERMS OF REFERENCE**

**Lease of Venue (Including Food) for the Conduct of the Strategic Development Exercise on Key Result Areas (KRAs) and Key Performance Indicators (KPIs) of the Professional Regulation Commission (PRC/Commission) with the Professional Regulatory Boards (PRBs)**

**Rationale**

The Strategic Development Exercise on KRAs and KPI of the Commissioner with the PRBs is scheduled on **13 to 14 December 2022** and will be conducted outside the PRC Central Office premises. To house the two-day activity, an external service provider will be contracted with the following terms and conditions:

**I. APPROVED BUDGET FOR THE CONTRACT**

The contractor should be able to provide the activity venue, food, and other basic amenities with the following specifications:

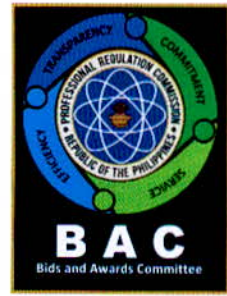
