 a) Purified water in 5-gallon capacity plastic bottle b) Purification involves multi-stage process of water filtration including and minimum of 16 stages Reverse Osmosis System. c) Supplier must ensure sufficient stock for consumption d) Free use of at least sixty (60) units hot and cold water non-spill dispensers e) Water dispensers shall be tower type and dispense both hot and cold water. f) Cost of plastic container: Free use / no deposit g) Containers must be in good shape, clean and well maintained h) Cap of container must be plastic sealed i) Delivery schedule and pick up of empty containers: twice a week, from Monday to Thursday only, and during working hours. j) During emergency: anytime delivery schedule k) No delivery charge. l) Monthly water test result issued by Department of Health (DOH) accredited laboratories. m) Free cleaning and maintenance services of the hot and cold dispensers, as may be required, including repair and replacement of its units and parts. n) Machines that can no longer be repaired shall immediately be replaced with a new unit. o) Payment shall be made to the supplier on a monthly billing basis (based on actual number of delivered bottles)
