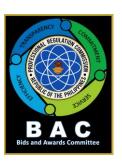

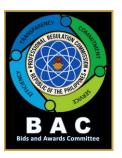

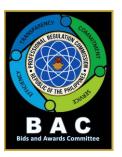

#### **TERMS OF REFERENCE**

Lease of Venue (Including Food) for the Conduct of the Strategic Development Exercise on Key Result Areas (KRAs) and Key Performance Indicators (KPIs) of the Professional Regulation Commission (PRC/Commission) with the Professional Regulatory Boards (PRBs)

#### Rationale

The Strategic Development Exercise on KRAs and KPI of the Commissioner with the PRBs is scheduled on 21 to 22 December 2022 and will be conducted outside the PRC Central Office premises. To house the two-day activity, an external service provider will be contracted with the following terms and conditions:

#### APPROVED BUDGET FOR THE CONTRACT I.

The supplier shall bid for all items described in this TOR, which shall not exceed the Approved Budget for Contract (ABC) of Seven Hundred Twenty Thousands Six Hundred Twenty-six Pesos and Twenty-eight Centavos (PhP720,626.28), inclusive of all applicable bank and government charges.

The contractor should be able to provide the activity venue, food, and other basic amenities with the following specifications:

#### **GENERAL REQUIREMENTS**

1. Event Date: 21 to 22 December 2022

4. Guaranteed number of participants: 50 pax

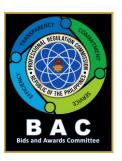
