**ALLOWING THE ACCEPTANCE AND PROCESSING OF APPLICATIONS FOR
VARIOUS LICENSURE EXAMINATIONS BEYOND THE PRESCRIBED DEADLINE FOR
SPECIAL AND JUSTIFIABLE CASES**

WHEREAS, Section 7 (d) of Republic Act No. 8981, or the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various Professional Regulatory Boards (PRBs) in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1927 (s. 2024) which sets forth the schedule of licensure examinations for the year 2025, including the opening and deadline of filing of applications to ensure orderly processing and scheduling of various licensure activities;

WHEREAS, certain circumstances beyond the control of both the applicants and the concerned Regional Offices (ROs)—such as suspension of work in government offices due to inclement weather, natural calamities, national or local holidays, and government orders, may prevent otherwise qualified applicants from filing their applications on time;

WHEREAS, there is a need to provide reasonable accommodation to affected applicants without reopening the application period, provided that such applicants have secured their online appointment schedule within the prescribed deadline;

WHEREFORE, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to authorize all concerned Regional Offices to accept and process examination applications strictly **WITHIN FIVE (5) WORKING DAYS** following the prescribed deadline for the filing of applications **only on special and justifiable cases** herein identified in this Resolution, and other similar conditions which hinder timely filing, **PROVIDED** that such cases are duly supported by appropriate documentary evidence from competent authorities, subject to evaluation of the concerned RO, and **PROVIDED** further that:

1. The applicants have secured and paid their online appointment schedule on or before the prescribed deadline for the filing of applications;
2. The RO concerned shall document the justifications for processed applications beyond the prescribed deadline, and encode the same in the remarks portion in the Licensure and Registration Information System (LERIS) account of processor/issuing officer; and
3. No reopening of the application system shall be undertaken beyond the prescribed deadline.

RESOLVED FURTHER, that the Regional Offices shall ensure that this accommodation will not affect the schedule nor compromise the integrity and orderly conduct of the examinations concerned, nor shall it prejudice applicants who have timely complied with the prescribed deadlines.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth implementation thereof.
