Relative to this, all examinees of Davao City are required to bring the following:

1. Notice of Admission
2. Two (2) or more pencils
3. Ball pens with BLACK ink only
4. One (1) piece long size brown envelope
5. One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)
6. Non-Programmable Calculator (please refer to the Commission Resolution No. 1809 s. 2024 or the “Updated List of Non-Programmable calculators allowed to be used in the Licensure Examinations.”) NOTE: ONLY ONE (1) BASIC CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM. ALL CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET BEFORE THE START OF THE EXAMINATION.
7. Examinees are required to wear the following attire every examination day:
MALE: *White polo shirt or shirts with collar, tucked-in (without any seal, logo or mark). Decent pants or slacks.*
FEMALE: *White blouse or shirts with collar (without any seal, logo or mark). Decent pants, slacks or skirts.*
8. For pregnant examinee, submit clearance from the OB-Gynecologists
 - ❖ Clearance should indicate that the examinee is cleared to take the licensure examination.
 - ❖ No OB-Gyne Clearance, No Exam.
9. Snacks and lunch packed in transparent containers.
 - ❖ Food deliveries are not allowed.
 - ❖ Schools, review center, co-examinees, or any other groups are not allowed to distribute food or drinks outside or inside the testing center premises, even during break time.

IMPORTANT REMINDERS

1. Examinees are prohibited to use **CALCULATORS** which are programmable or with embedded functions especially **CASIO FX991ES**, **CASIO FX-991ES plus** and **CASIO FX-570ES Plus**, cellular phone, ear plugs, bluetooth, and other electronic gadgets/devices. Examinees will be required to **TURN OFF** their mobile phone/s before entering the examination venue. Phone/s must be placed inside their bags and can only be used again upon exiting the venue;
2. Books, notes, review materials, and other printed materials containing coded data/information/formula are not allowed inside the testing center premises. Bringing of the said items inside the examination venue will be considered as **CHEATING** or an **ACT OF DISHONESTY**. If an examinee is found guilty, his/her examination papers shall be cancelled and shall either be suspended or debarred from taking future examinations.
3. Read carefully and follow the instructions on your **NOTICE OF ADMISSION** and **EXAMINEES GUIDE**.
4. Avoid using Plastic PET Bottles, plastic wrappers and food packages. This is in observance with the eco-solid waste initiatives of our partner schools.
5. Personal belongings brought by an examinee shall be for his/her own account. The PRC will not be answerable for any such item or personal belonging that might be lost during the examination without fault or negligence on its part.
6. **This licensure examination will be administered through a Computer-Based Licensure Examination (CBLE).**

CONDUCT OF COMPUTER-BASED LICENSURE EXAMINATION IN THE NATIONAL CAPITAL REGION, DAVAO, LEGAZPI AND LUCENA AND PAPER-AND-PENCIL LICENSURE EXAMINATION IN BAGUIO, CAGAYAN DE ORO, CEBU, ILOILO, PAMPANGA, TACLOBAN AND ZAMBOANGA FOR THE OCTOBER 2024 CHEMISTS LICENSURE EXAMINATION

WHEREAS, Section 7 (d) of Republic Act (R.A.) No. 8981, or the "PRC Modernization Act of 2000", empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, Section 7 (q) of R.A. No. 8981 also empowers the Commission to fully computerize all licensure examinations given by the various Professional Regulatory Boards and other operations of the Commission;

WHEREAS, the Commission initiated the project for the in-house Computer-Based Licensure Examinations (CBLE) towards the full computerization of the conduct of the various professional licensure examinations;

WHEREAS, pursuant to Resolution No. 1728 (s. 2023), the Chemists Licensure Examination (ChLE) is scheduled on October 14 and 15, 2024 in various testing centers;

WHEREAS, the Commission issued Resolution No. 1836 (s. 2024) revising the schedule of licensure examinations from August to December 2024 wherein the ChLE will be conducted specifically in the National Capital Region (NCR), Baguio, Cebu and Davao;

WHEREAS, Resolution No. 1891 (s. 2024) was issued increasing the number of testing centers for the licensure examinations scheduled from October to December 2024;

WHEREAS, the Professional Regulatory Board of Chemistry and the Licensure Office recommend to the Commission the conduct of a hybrid ChLE: CBLE in NCR, Davao, Legazpi and Lucena; and conventional paper-and-pencil licensure examination in Baguio, Cagayan de Oro, Cebu, Iloilo, Pampanga, Tacloban and Zamboanga this October 2024;

WHEREFORE, in view of the foregoing, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to **CONDUCT** the **Chemists Licensure Examination through Computer-Based Licensure Examination in the National Capital Region, Davao, Legazpi and Lucena, and Paper-and-Pencil Licensure Examination in Baguio, Cagayan de Oro, Cebu, Iloilo, Pampanga, Tacloban and Zamboanga on October 14 and 15, 2024.**

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.

- Bags of any kind (ladies' bag, shoulder bags, attaché case, backpacks, etc.)
- Other examination aides not stated in this program.

All personal belongings of the examinees shall be surrendered to the proctor and shall be placed in a secured space within the examination room.

The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57 (s. 2020) shall be strictly observed.
